

Terms & Conditions of Sale

How To Order — Your order should contain a full description of each item, indicating its figure number, size, threading, and any other applicable information. Please include shipping instructions with exact destination. Written confirmations of verbal orders must be clearly marked as such to avoid duplication.

Minimum Order — \$25.00 net selling price, plus applicable taxes and freight.

Payment — Net 30 days on approved credit. Past due accounts are subject to a 1-1/2% per month (18% per annum) service charge, or the maximum lawful rate in your state. Shipments will not be made to accounts with a past due balance.

We also accept all major credit cards.

Delivery — Every effort is made to deliver all orders in a timely manner, but we are not responsible for delays due to parts or material shortages, labor disputes, transportation delays, acts of God, or any other similar cause beyond our reasonable control. Products listed in this catalog are not necessarily to be construed as stock items in all cases.

Freight Terms — FOB shipping point with no freight allowance unless quoted otherwise. Title passes immediately to buyer upon delivery of goods to carrier.

Returned Merchandise — No material may be returned without our prior consent and issuance of a Return Goods Authorization (RGA). Returned goods, if accepted, are subject to a minimum 30% handling charge. Goods must be in new and original condition, subject to inspection, and returned to us freight prepaid. Credit for returned goods will apply to future purchases only.

Requests to return merchandise more than six (6) months after the original date of shipment are subject to management approval. No merchandise may be returned after twelve (12) months, for any reason.

Non-stock, specially manufactured goods, or items ordered in excess of normal stocking quantities may not be canceled or returned for credit.

Claims & Shortages — All claims for error or shortage must be made within 10 days after receipt of merchandise. Claims for goods damaged in transit are the purchaser's responsibility and must be made against the delivering carrier.

Warranty — All goods offered for sale have been manufactured by others and are sold subject to their respective manufacturers' specifications, representations, and warranties. We assume no responsibility for the accuracy of such manufacturers' statements. A copy of the manufacturer's warranty, if any, will be provided upon request. In the event Buyer should submit a timely and valid claim under such a warranty, we will cooperate in helping Buyer process such a claim to the extent that we are able, provided we are not required to incur any expense in doing so.

Disclaimer — The descriptions contained in this list price catalog are for identification purposes only and do not express or imply that the products are merchantable or fit for a particular purpose. It is the user's responsibility to determine the suitability of the product for its intended use.

Taxes — All prices and quotations are subject to applicable state and/or local sales taxes unless a valid tax exemption certificate is provided.

Liability — Liability is limited to obligation of Seller's warranty. Seller is not liable for any loss, damage, or additional expense, whether based upon warranty, damage, contract, or negligence attached to the design, manufacture and sale of products or of the engineering or specifications of the Buyer.

Controlling Provisions — These terms and conditions control with respect to any purchase order placed with the Seller. No modification, waiver, alteration, or addition to these terms shall be valid as part of Buyer's purchase order unless individually acknowledged and accepted in writing by an authorized representative of the Seller. It is agreed that all orders placed with Seller will be paid in full and in accordance with Terms and Conditions as stated above. Should Buyer not pay Seller according to same, it is understood that credit privileges may be withdrawn and interest will be charged at the full lawful rate. If it becomes necessary to obtain collection assistance, Buyer agrees to pay all collection costs and any attorney fees or court costs.
